



ECO 8W LED Dimmable CCT Downlight – 22828/05

Before first using your new Downlight, it is most important that you read and follow these instructions, even if you feel you are quite familiar with this type of product. Keep this document for future reference.

INSTRUCTION MANUAL

General Installation Information:

- All wiring and installation of the LED downlight must adhere to the latest local and national wiring rules. eg. **AS/NZS 3000** Electrical Installations. If unsure, please contact a licensed electrician.
- Before installation, check the installation location in the ceiling has access to a socket outlet which is connected to a wall light switch and/or dimmer. If it does not, please contact a licensed electrician to arrange installation of the socket outlet, wall light switch and dimmer before continuing.
- The LED downlight is rated **IP44** only after it is fully installed, this must be maintained during installation. NOTE: The back part of the LED downlight module is rated **IP20**.
- Select a suitable location for installation:
 - The mounting point must support 2 times the weight of the downlight.
 - This LED downlight is suitable for indoor or outdoor use, if it is installed under cover or under eaves.
- Check whether the downlight has been damaged during transport. Do not operate/install any product which appears damaged in any way. Return the complete product to the place of purchase for inspection, repair or replacement.
- Ensure power to the circuit you are working on has been switched OFF before commencing any electrical work.
- Do not perform modification to the unit.
- If the supply cord is damaged it should be replaced by the manufacturer or qualified person to avoid a hazard.
- Lay out all the components on a smooth surface and make sure there are no components missing before assembling. If parts are missing, return the complete product to the place of purchase for inspection or replacement.
- Failure to follow these instructions may void the warranty.

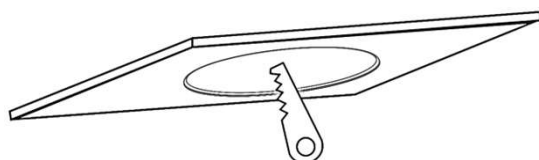

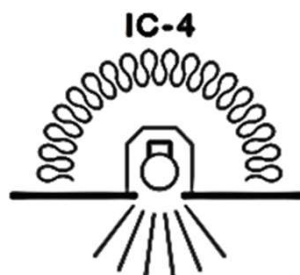
- Remove product from packaging.
- **NOTE:** Before installing the downlight, plug the downlight into a socket outlet to ensure the downlight is working correctly.
- Cut the installation hole of Ø90mm into the ceiling. (Fig.1).
- Select your preferred colour temperature by sliding the CCT switch on the top of the downlight.
- Feed the supply cord through the ceiling hole and connect the downlight plug to the socket outlet in the ceiling. (Fig.2.).
- Push the springs up and put the downlight module up through the cut-out hole and into the ceiling (Fig.3.).

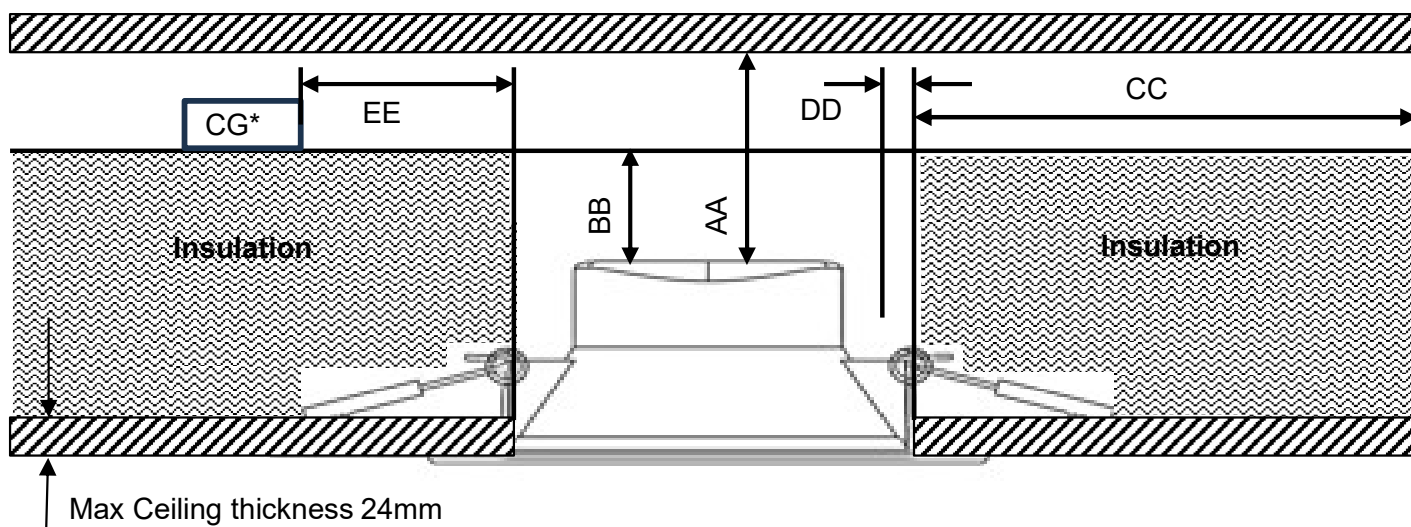

SAFETY TIPS

- To avoid injury or damage to the downlight, ensure that power leads and screws are secure before connecting the power.
- Select a suitable location away from liquids and hazards.
- To clean, wipe with a soft damp clean cloth. **Do NOT** soak or immerse the product in water or other liquids.
- Ensure that the downlight does not come in contact with corrosive chemicals/solvents or abrasive cleaners etc

WARRANTY

Brilliant Lighting warrants this product against defects in manufacture and workmanship for a period of 3 years from date of purchase or as specified on the packaging. This warranty is only valid for products installed by a qualified electrical contractor and operated within the guidelines specified by Brilliant Lighting, and within the correct operating voltage ranges as stated on the product's rating label.

Warranty does not include damage or loss arising from incorrect installation, operation or maintenance of this product, damage caused through modification, incorrect installation, service by unqualified or unauthorised personnel or lack of regular maintenance and cleaning.
